### Note:-

1. The Claim received on dated 09.06.2022 of State Bank of India SARBI Delhi (Financial Creditor). Liquidator has send the email on 11.06.2022 to the Claimant that last date of submission of claim was 04.05.2022.

The State Bank of India SARBI Delhi (Financial Creditor) has filed an appeal under section 42 & 60 (5) of IBC, 2016 before Hon'ble NCLT Court for condonation of delay and direction to accept the claim. The matter was heard on dated 07.07.2022. The Hon'ble NCLT Court has allowed the claim with condonation of delay subject to remittance of cost Rs. 10,000 to the Liquidator for Liquidation Cost.

The Liquidator has sent email on dated 02.08.2022 & reminder dated 10.08.2022 to SBI and discussed in person on 05.08.2022 for submitting supporting information/documents to verify the claim. But no response has received.

2. The Claim received on dated 24.05.2022 of IIFL Finance Limited (Financial Creditor). Liquidator has send the email dated 30.05.2022 to the Claimant that the last date of submission of claim was 04.05.2022

The IIFL Finance Limited has filed an Appeal before the Hon'ble NCLT Court Under Section 42 & 60 (5) of IBC, 2016 against the Rejection of Claim by the Liquidator. The Appeal is not listed till now.

3. The Claim received on dated 10.05.2022 of Hoshiyar Singh (Financial Creditor) and not in prescribed format. The Liquidator has send the email on 30.05.2022 to the Claimant that last date of submission of claim was 04.05.2022

The Liquidator has send the email on dated 28.07.2022 and informed him that an appeal U/S 42 of IBC, 2016 may be filed before NCLT Court for condonation of delay in submission of claim.

4. The Claim has received from Speech and Hearing Care Private Limited (Operational Creditor) on dated 07.05.2022. The Liquidator has send the email dated 07.05.2022 to the Claimant that last date of submission of claimwas 04.05.2022
